PROTECTION OF PERSONAL DATA

In terms of the provisions of the Law, and in particular the Data Protection Act (Chapter 440 of the Laws of Malta), I declare that in the processing of personal:

- I will process personal data in accordance with the rules, bye-laws, regulations and decisions issued by the Malta Football Association;
- I will apply the principles of personal data protection as defined in the Law and in particular by taking the necessary measures to protect personal data accessed and processed as a user of COMET;

Regulations on the use of COMET

1. COMET – Competition Management Expert System is an online platform used by the Malta Football Association for the management of player registration, competitions, disciplinary processes, and as a single integrated repository of data.
2. “Authorisation” means the provision of login credentials by the Malta Football Association to a user of COMET. In the case of a user acting on behalf of a Member Club or a Member Association, such user shall have the unconditional permission from the President and Secretary of the Member Club or Member Association concerned to act on behalf of the same.
3. Such authorisation shall be withdrawn if it is established that the user no longer has the permission of the Member Club or Member Association to act on its behalf.
4. Authorised users of COMET have the obligation to ensure the accuracy and the authenticity of all data that they enter in the COMET system.
5. Authorised users of COMET processing data are bound to follow the rules, bye-laws, regulations and decisions issued by the Malta Football Association, including those intended to ensure protection of personal data as provided hereunder.
6. Authorised users acting on behalf of Member Clubs shall enter in COMET immediately and accurately the relevant records of matches involving their respective club. In case of force majeure, these records shall be entered no later than 3 (three) hours after the end of the match.
7. Authorised users of COMET shall protect the personal data of players and officials accessed and/or processed in the course of usage of the system. Such personal data shall at all times considered confidential.
8. COMET users are subject to the jurisdiction of the Malta Football Association and shall observe all the rules, bye-laws, regulations and decisions of the Association.
