# CONFIDENTIALITY AGREEMENT

Dear Sir,

We write to you in connection with your club's application for a Club Licence ("Licence") for the **season 2022/23** under the terms of the Club Licensing System (the "Application").

For us to be able to evaluate and to reach a decision on the Application, you have already made on behalf of your Club, the information (the "Information") relating your club and related undertakings shall be subject to the following:

- 1) In consideration of your making the Information available to us, we hereby undertake that such Information shall be kept strictly confidential by the Malta Football Association, its statutory bodies and its employees and/or agents (and particularly by those employees working in our Club Licensing Department and other appointed advisors) and shall not be disclosed directly or indirectly to any third party, external to those defined in the MFA Statute, Bye-Laws and Regulations, (by whatever means) save:
  - (a) as is necessary for the evaluation of the Application, and then only on the condition that said external third party undertakes to keep such Information as is disclosed confidential on the same terms as set out in this letter.
  - (b) for the purpose of taking legal advice.
  - (c) as may be required by any court of competent jurisdiction.
  - (d) as agreed to in advance in writing by you.
- 2) In the interests of maintaining said confidentiality, we shall ensure that all employees involved in the licensing process and other appointed advisors involved in the evaluation of the Application shall, as soon as is reasonably practicable hereafter, execute a confidentiality undertaking. We agree to provide you with copies of all such executed undertakings upon your request.
- 3) We shall use the Information solely for the purposes of evaluating the Application and any subsequent discussions with you in relation to the Application save:
  - a) as is necessary to deal with any possible breach of MFA, FIFA or UEFA Statutes, or MFA, FIFA or UEFA Regulations, Rules and Bye-Laws.
- 4) For the avoidance of doubt, this agreement shall not apply to any information which is or becomes publicly available, except as a direct or indirect result of a breach by us of the obligations contained in this agreement.

- 5) In this letter, the word "Information" includes information which is made available by you or on your behalf, orally or in writing or in any other way (including information stored on computer or any other medium of any kind), information which is apparent on any visit to a property owned or occupied by your club, analyses or memoranda prepared by us or on our behalf containing any information referred to in this paragraph.
- 6) Each signatory to this letter hereby represents and warrants to the other that:
- (a) it has full power and authority to enter into and perform all such obligations as are required by this letter; and
  - (b) it has taken all necessary actions to authorize the execution and performance of this letter in accordance with its terms.

The statement should be printed in all match programmes and displayed permanently and prominently around the ground.*
2. *Make public address announcements condemning racist chanting at matches.*
3. *Make it a condition for season-ticket holders that they do not take part in racist abuse.*
4. *Take action to prevent the sale of racist literature inside and around the ground.*
5. *Take disciplinary action against players who engage in racial abuse.*
6. *Contact other associations or clubs to make sure they understand the Association's or club's policy on racism.*
7. *Encourage a common strategy for stewards and police to deal with racist abuse.*
8. *Remove all racist graffiti from the ground as a matter of urgency.*
9. *Adopt an equal opportunities policy in relation to employment and service provision.*
10. *Work with all other groups and agencies, such as the players' union, supporters, schools, voluntary organizations, youth clubs, sponsors, local businesses, police and other public authorities, to develop proactive programmes and make progress to raise awareness of campaigning to eliminate racial abuse and discrimination.*

#### LEGAL VALID DECLARATION

- E) That our Club shall at all times adhere to the provisions laid down in *MFA CLUB LICENSING REGULATIONS FOR PARTICIPATION IN UEFA CLUB COMPETITIONS APPLICABLE TO PREMIER DIVISION MEMBER CLUBS* and that during the validity of the Licence our Club shall strictly conform with all the criteria related to the UEFA Licence;
- F) That our Club shall at all times adhere to the provisions laid down in the *UEFA Club Licensing and Financial Fair Play Regulations*;
- G) Our Club's reporting parameter are in accordance with Art 43 of the *MFA CLUB LICENSING REGULATIONS FOR PARTICIPATION IN UEFA CLUB COMPETITIONS APPLICABLE TO PREMIER DIVISION MEMBER CLUBS*
